**Minutes:**

**President's Report:**

**Background Checks:** Jeffrey Goodwin presented feedback on the recent approval of the background check for prospective members and urged the Board to rescind the background check approval; and instead, match each prospective member with a sponsor who would then thoroughly vet the proposed member before recommending membership. Their goals are to increase our membership by 20; recognize sponsors every quarter; increase the Membership Committee to 5 members; and have the Membership Committee do the proposing of prospective candidates for membership to the Board and club members.

Gunnvor moved that we approve and sign the Resolutions for Refinancing Construction Loan; Casey seconded; motion passed. **Community Service Report:**

**Operation Warm:** Jody reported that she would like volunteers for setup at Trinity Lutheran Church by 11:00. There will be free flu shots, free haircuts provided by Jody's crew at Accent on Appearances, gift cards for shoes drawings, lots of new and gently used coats, and a variety of vendors there with information on services available.

**Santa Breakfast:** Gunnvor reported that the breakfast will be Dec. 5<sup>th</sup>, 8:00 – 11:00, with setup taking place the day before. The club will be decorating the venue, stuffing stockings, etc.

**Vocational Service Report:**

Ken reported that the house is now heated and taped; painting and woodwork is next; shrubs and some trees are needed; a fence needs to be built on one side; and that they are ready to file the permit for the next house to build.

**Club Service Report:**

Edy reported that we are not able to meet at the college on January 14<sup>th</sup> and 28<sup>th</sup>, February 18<sup>th</sup>, and March 3<sup>rd</sup>. It was suggested that Edy check with Verdant Health, since they have rooms and they do not charge for use, and the Lynnwood Convention Center.

It was also announced that Rick Steves, a well-known travel business owner, TV personality, and member of Trinity Lutheran Church, donated 2 million dollars to go toward the building of the new Community Center.

- 5) The board authorizes the officers to be signers on the new construction loan and any one of the listed officers are hereby authorized to draw upon the construction loan.
