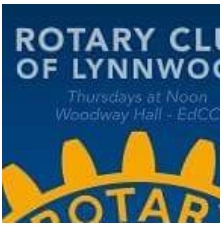


2018 Classic Car Raffle Official Rules
Sponsored by the Rotary Club of Lynnwood.



This raffle contest is operated by the Rotary Club of Lynnwood (RCL) under State of Washington Raffle License #02-20858. The (RCL) is a fellowship of leaders who voluntarily support others through our Vocational, Community, International and Youth Service activities. All raffle proceeds go to support this mission. The Lynnwood Rotary Community Foundation (LRCF), through our joint operating agreement will receive and administer the raffle proceeds for the RCL.

RAFFLE ENTRIES Single raffle entries are \$10.00. 125 discounted packets of six entries are available for \$50.00. There is no limit on the number of entries an entrant may purchase. Checks or money orders should be made payable to Lynnwood Rotary Community Foundation (or LRCF 91-1495396). An entry shall not occur and be binding on the Lynnwood Rotary Community Foundation until funds received for the same have cleared the bank. Credit cards may, or may not be accepted, depending on the resources available at specific events. In accordance with Internal Revenue Service rules, entry fees are not tax deductible.

Each entry, or entries into the raffle drawing, shall receive a pre-numbered ticket and the person to whom the entry is registered shall be the "Entrant." Although more than one name may be provided on the entry ticket form, the entry shall be registered to the first name listed, who shall constitute the sole Entrant for that ticket. The winning Entrant shall be the "winner" of the prize. Transfer of prize ownership will be made to the Entrant. The winner must supply his/her social security number before the prize is tendered. It is the sole responsibility of the Entrant to allocate a winning prize to other participants in case of a multiple entry registration, and the winning Entrant shall hold harmless and indemnify the Rotary Club of Lynnwood and the Lynnwood Rotary Community Foundation against any claims or disputes of joint or several ownership of the raffle prize.

By submitting an entry, each purchaser acknowledges having read and agrees to abide by these 2018 Classic Car Raffle Official Rules.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW This raffle is conducted in accordance with gaming laws enacted and enforced by the State of Washington, Snohomish County, and/or the City of Lynnwood, and is void in areas prohibited or restricted by law.

The Rotary Club of Lynnwood/ The Lynnwood Rotary Community Foundation, its members, officers, directors, agents, and representatives and their parent organizations, affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for:

- (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries
- (ii) failed, returned, or misdirected notifications based on inaccurate information provided by the winner; or
- (iii) telephone, electronic, hardware, or software program, network, Internet, or computer malfunctions, failures, or difficulties resulting from participation in this Raffle of otherwise;
- (iv) errors in transmission;
- (v) any condition caused by events beyond the control of the Rotary Club of Lynnwood / The Lynnwood Rotary Community Foundation that may cause the Raffle to be disrupted or corrupted
- (vi) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of a prize, or from participation in the Raffle; or
- (vii) any printing or typographical errors in any materials associated with the Raffle.

If the above occurs, the Rotary Club of Lynnwood reserves the right to remedy any such action, disruption, or circumvention in a manner, determined solely by the Rotary Club of Lynnwood that is

fair and equitable to all Raffle participants.

ELIGIBILITY Entrants must be 18 years of age or older on, or before, May 1, 2018 (the official start date of raffle). The Entrant must supply his/her social security number to receive prize. If an Entrant's check or credit card is dishonored prior to the drawing, the entry ticket will be declared invalid, until a replacement entry fee is received. However, such replacement entry fee must be received with sufficient time before the official drawing to verify the deposit into LRCF bank account. **Any bank charges incurred by the Rotary Club of Lynnwood / The Lynnwood Rotary Community Foundation must also be reimbursed as part of the replacement funds.**

ENTRIES A maximum of 5,000 entries will be collected. An entrant's actual chance of winning will be the number of entries purchased divided by the total number of entries collected which will not be known until the official drawing date or until the maximum tickets have been collected. **In no event will less than 4,000 entries be collected by the date of the drawing. Should fewer than 4000 entries be collected by December 8, 2018, the raffle will be declared null and void. In that event, all entrants holding valid entries will be notified of the drawing cancellation. Entrants will have their option to have their funds returned or to convert them to a tax-deductible donation to the Lynnwood Rotary Community Foundation. Failure of an entrant to request a refund of their entry fee within sixty days (60) notice of the drawing cancellation will constitute their election to treat the funds as a tax-deductible contribution to the Lynnwood Rotary Community Foundation.**

DRAWING The raffle drawing will take place on December 8, 2018, at Acura of Lynnwood, 21515 WA-99, Lynnwood, WA 98036. **If the maximum entries have not been collected prior to December 1, 2018, check or credit card entries will still be accepted as of that date, or entries paid in cash will be accepted until five minutes before the actual drawing.** The winning entrant does not need to be present at the time of the drawing and will be notified by the RCL within 7 business days of the drawing via the documentation provided on the entry

PRIZE The 2017 Classic Car Raffle vehicle is a 1965 Ford Mustang, VIN 5F07C631863, Warranty plate 65A P 26 15B 33 6 1. The vehicle is Poppy Red with a 289 4bbl engine and 4 speed manual transmission. Prize is won "AS IS", "Where Is" and the RCL / LRCF accepts no responsibility or liability regarding the condition or operational aspect of the prize. Alternatively, the winning entrant may select \$15,000 in cash (net of any required IRS withholding). The winner must claim their prize within 30 days from notification, per directions provided in the notice. He/she is responsible for picking up the car on a date, time and site designated by the RCL. Failure to claim the prize within 30 days will result in forfeiture of the prize and all claims against the RCL / LRCF.

All federal, state and local income, sales and/or excise taxes, fees, assessments and like charges associated with the prize, are the responsibility of the holder of the winning entry.

The IRS requires the LRCF to collect withholding tax from the winner at 24% of the appraised or cash value of the prize and such funds must clear deposit with LRCF bank account prior to transfer of prize ownership. The winner must complete a W-9 form and a W-2G before receiving prize. The winner must provide the LRCF with his or her current name, address, and taxpayer identification number. This information needs to be verified from the person's driver's license, social security card, voter registration card, or other proper information.
